General Notice of Registrable Interests

Any land where the landlord is the Town Council, and you, or a firm in which you are a partner, or a company of which you are a paid director is the tenant

Membership of any Body whose principal purpose is to influence public opinion or policy or which, in your view, might create a conflict of interest in carrying out your duties as a Town Councillor. <i>(for example political party; trade union, professional association, local action forum, civic society or interest group such as National Trust, RSPB, Greenpeace, CPRE or membership of the Freemasons or similar body)</i>	
Any easement, servitude, interest or right in or over land which does not carry with it a right for you (alone or jointly with another) to occupy the land or to receive income. This includes options to purchase which you have on land in Newby & Scalby Parish	
Any gifts or hospitality worth more than an estimated value of £25 which you have received by virtue of your office

DECLARATION

1 I recognise that it is a breach of the Council's Code of Conduct to:-

- (1) Omit information that ought to be given in this notice
- (2) Provide information that is materially false or misleading
- (3) Fail to give further notices in order to:
 - bring up to date information given in this notice
 - declare an interest that I acquire after the date of this notice and have to declare

and that any breach of the Code of Conduct can be referred to the Monitoring Officer. If I fail to declare a pecuniary interest this may be referred to the police to investigate as a criminal offence.

2 I understand that failure (without reasonable excuse) to register or disclose any disclosable pecuniary interest in accordance with Section 30(1) or 31(2), (3) or (7) of the Localism Act 2011, or participating in any discussion or vote in contravention of Section 31(4) of the Localism Act 2011, or taking any steps in contravention of Section 31(8) of the Localism Act 2011 is a criminal offence and risks a fine not exceeding level 5 on the standard scale (currently £5,000) or disqualification as a Member for a period not exceeding 5 years.
